Application for Temporary Street Closure (Class B) Neighborhood Block Party Permit. (PAMC 10.10.010)

****Please Note: The Palo Alto Police Department must receive completed applications at least ten (10) days in advance of the scheduled date of closure.**

Class B-Temporary Street Closure, defined:
 A block party or similar occurrence not exceeding one city block on other than arterial or collector streets, and along which at least two-thirds of the area is in a residential zone, and to which a majority of owners, residents or tenants of properties fronting upon such area consent, which is sponsored solely by residents, tenants or owners, and is not for commercial or advertising purposes or profit shall be designated Class B.

Conditions of Closure:
Applicants are responsible for providing and removing such barricades/barriers and warning signs necessary to close the street safely. Half of the roadway's width for the entire length of the closure shall remain clear of objects (BBQ's, tables, etc.) in order to accommodate public safety vehicles in the event of an emergency. Applicants must provide the collection and removal of all trash, garbage and litter caused by or arising out of such temporary street closure. Event activities shall not create a public or private nuisance or an undue hazard or disturbance to the public peace, tranquility, health welfare, safety or morals, or create an excessive burden on police or fire or other public operations equipment or facilities. Palo Alto's Noise Ordinance is enforced on a complaint basis. Block Party Permits provide no waiver to the Noise Ordinance. In the interest of safety, permits will not be issued or valid for times of darkness. Alcoholic beverages shall not be sold in conjunction with the closure.

12. As applicants of the proposed closure, I/We certify that a majority of owners/residents/tenants of properties fronting on such streets have consented to the closure. I/We also certify that we have reviewed the "Conditions of Closure" and "Class-B Temporary Street Closure, defined" and understand the restrictions that apply to neighborhood block parties. I/We are also aware that Class B-Temporary Street Closure Permits can be immediately revoked if Penal Code Section 415 (disturbing the peace) or Palo Alto Municipal Code Chapters 9.10 and 9.12 (noise ordinance) are violated.
